The City of Roswell is accepting sealed bids from qualified contractors for the Warsaw Road Sidewalk Project. Sealed bids will be received no later than **Wednesday, July 7, 2010 at 2:00 PM** at the City of Roswell Purchasing Division, Roswell City Hall, 38 Hill Street Suite 130, Roswell, Georgia 30075, at which time they will be opened and publicly read aloud. Bids received after the above date and time, or in any location other than the Purchasing Division, will not be considered.

There will be a pre-bid conference **Thursday, June 24, 2010 at 10:00 AM**. This conference will be held in the Room 220, Roswell City Hall, 38 Hill St., Roswell, GA. 30075. Attendance is not required, but highly recommended.

This project consists of filling sidewalk gaps along the east side of Warsaw Rd to provide additional pedestrian connectivity within 0.5 miles of Mimosa Elementary School. The typical section consists of a minimum 2' bike shoulder; 24" curb and gutter, a variable-width grass buffer and a 5' wide sidewalk. This project is approximately 1160 feet long. The project starts from just north of Holcomb Bridge Road/SR 140 and ends at Park Bridge Lane/Tahoe Run. MARTA funds will be used to complete the project.
